

## 2020 Toronto International Boat Show

### CNE Prize Grand Prize #2

#### Toronto Getaway

#### Official Online Contest Rules

- 1. Agreement:** These rules govern the Toronto Boat Show CNE Grand Prize #2 – Toronto Getaway, (2) Two-nights accommodation at the Westin Harbour Castle Hotel, including, meal credit and shopping spree at the 2020 Toronto International Boat Show (“Contest”). No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest rules and the decisions of the Contest judges, which decisions shall be final and binding upon all entrants.
- 2. Sponsors:** The Contest sponsors (“Sponsor”) are Canadian Boat Shows Inc., owner of the Toronto International Boat Show.
- 3. Eligibility:** To enter and to be eligible to win, an individual must be a legal resident of Canada (excluding Quebec) and must have reached the age of majority in his or her province or territory of residence. One entry per person. Employees and their immediate family members (parents, siblings, children, spouse), and persons domiciled with an employee of the Contest Sponsor, its marketing agencies, and judges, are ineligible.
- 4. Contest:** To enter the Contest like, share or comment on Facebook @TorontoBoatShow The Contest begins at 11:00 am EST, Friday, August 16, 2019 and ends at 7:00 pm EST on Monday, September 2, 2019. The potential winner will be chosen by random draw, which will take place on Tuesday, September 3 before 11:59 pm. The potential winner will be contacted via social media by a representative of the Sponsor, and must reply within 48 hours to maintain eligibility. If the potential winner cannot be contacted within this time period or fails to respond to any attempted contact, such potential winner will be disqualified, his or her entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry. In order to be eligible to win, the potential winner must correctly answer a mathematical skill-testing question, without assistance or mechanical or electronic aid.

6. **Release:** Prior to receiving the prize, the potential winner will be required to show valid photo ID and to sign a declaration of eligibility and release form releasing the Sponsor and its related parties from any and all liability in connection with the Contest and/or the prize, confirming compliance with the rules and consenting to the use of his or her name and image in any and all forms of media, without further compensation, in any publicity carried out by the Sponsor and/or its advertising and promotional agencies. Such Release must be returned via fax/email within ten (10) business days of the date on the covering letter and/or email accompanying the Release. If the Release is not returned within ten (10) business days of the date on the covering letter and/or email accompanying the Release, the Contest prize will be forfeited.
7. **Privacy:** We use your personal contact information to administer contests, including contacting, announcing and promoting prizewinners. The Contest is run in compliance with CASL and the Canadian Boat Show's Inc. privacy policy, which may be found in full by clicking on Privacy Policy, either on the main Contest and Giveaways page, or in the footer of the home page of TorontoBoatShow.com.
8. **Banning:** The Sponsor may, in its sole discretion, prohibit any person from entering the Contest whom it believes to be abusing the rules. Such abuse includes entering false information and entering more than once.

This Contest is governed by the laws of Ontario and the laws of Canada applicable therein and is void where prohibited by law. The Sponsor reserves the right to cancel or modify the Contest or the Contest rules at any time without notice. The Sponsor reserves the right to substitute any prize or portion of the prize with a prize of equal or greater value. All prizes are awarded as-is and no warranties or guarantees are implied or expressed, beyond the standard manufacturer's

warranty. Sponsor is not liable for any lost, late, misdirected or stolen entries or inability to process entries, or any errors, damage or negligence that may arise in connection with this Contest, including technical failures on the website or Contest software, viruses, website disruptions, malfunctions or website down-time, human error or property damage incurred by any Contest entrant. Sponsor is not responsible for any errors or omissions in printing or advertising this Contest.
