

2018 Toronto International Boat Show Contest Boat Show Ticket Packages

Official Online Contest Rules

- 1. Agreement:** These rules govern the 2018 Boat Show Ticket Packages Contest (“Contest”). No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest rules and the decisions of the Contest judges, which decisions shall be final and binding upon all entrants.
- 2. Sponsor:** The Contest sponsor (“Sponsor”) is Canadian Boat Shows Inc., owner of the Toronto International Boat Show.
- 3. Eligibility:** To enter and to be eligible to win, an individual must be a legal resident of Canada (excluding Quebec) and must have reached the age of majority in his or her province or territory of residence. One entry per person. Employees and their immediate family members (parents, siblings, children, spouse), and persons domiciled with an employee of the Contest Sponsor, its marketing agencies, and judges, are ineligible.
- 4. Contest:** To enter the Contest, access the Contest website at <http://www.torontoboatshow.com/highlights/contests-giveaways/>, read these Contest rules, and follow the instructions to enter during the Contest period (a valid email address will be required). The Contest begins at 11:59 pm EST, October 12, and ends at 12 noon EST on Monday, January 8, 2018. The potential winner will be chosen by random draw, on Monday, January 8, 2018. The potential winners will be contacted by email by a representative of the Sponsor, and must reply within 48 hours to maintain eligibility. If the potential winner cannot be contacted within this time period or fails to respond to any attempted contact, such potential winner will be disqualified, his or her entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry.
- 5. Prizes:** *Win 1 of 20 prize packs of 4 tickets to the 2018 Toronto Boat Show (January 13 to 21, 2018). Each prize pack valued at \$80. Valid January 13 to 21, 2018. Prize must be redeemed during time stated in these rules and will not be rescheduled or substituted. If the winner is unable or unwilling to accept or otherwise redeem the prize on the terms it is awarded, the prize shall be forfeited and no cash or substitutes will be provided in whole or in part.*
- 6. Privacy:** We use your personal contact information to administer contests, including contacting, announcing and promoting prizewinners. The Contest is run in compliance with Canadian Boat Show’s Inc. privacy policy, which may be found in full by clicking on Privacy Policy – either on

the main Contest and Giveaways page, or in the footer of the home page of TorontoBoatShow.com.

7. **Banning:** The Sponsor may, in its sole discretion, prohibit any person from entering the Contest whom it believes to be abusing the rules. Such abuse includes entering false information and entering more than once.

8. **Other:** Odds of winning depend on the number of eligible entries received. This Contest is governed by the laws of Ontario and the laws of Canada applicable therein and is void where prohibited by law. The Sponsor reserves the right to cancel or modify the Contest or the Contest rules at any time without notice. All prizes must be accepted as awarded, are non-transferable and are not convertible to cash. The Sponsor reserves the right to substitute any prize or portion of the prize with a prize of equal or greater value. All prizes are awarded as-is and no warranties or guarantees are implied or expressed, beyond the standard manufacturer's warranty. Sponsor is not liable for any lost, late, misdirected or stolen entries or inability to process entries, or any errors, damage or negligence that may arise in connection with this Contest, including technical failures on the website or Contest software, viruses, website disruptions, malfunctions or website down-time, human error or property damage incurred by any Contest entrant. Sponsor is not responsible for any errors or omissions in printing or advertising this Contest. Use of any automated system including robotic or form filling software to enter or participate in this Contest is prohibited and will result in disqualification of all entries by anyone using such assistance.
