

Required Insurance

As an exhibitor or EAC participating at **Toronto International Boat Show 2026** you must have adequate liability insurance to protect the attending public, the show organizer and yourself. To participate in the event, exhibitors and EAC's must provide proof of coverage meeting the below requirements.

All participants are required to have valid insurance coverage. Please ensure that you submit an approved certificate of insurance by January 6th 2026. Participants who do not provide the required documentation by this date will be automatically enrolled in an event-specific insurance policy at a cost of \$159.

Requirements for all

- The policy needs to be in effect from **Jan 9th, 2026** through **Jan 28th, 2026**
- Comprehensive General Liability to cover bodily injury and property damage to third persons, including Personal & Adv Injury limits, and Products and Completed Operations coverage of not less than **two million dollars (\$2,000,000) per occurrence and two million dollars (\$2,000,000) aggregate.**
